The Burlington Town Council held a regular monthly meeting on Tuesday, November 10, 2020 at 7:00 p.m. at Town Hall with Council's Steve Michael, and Jim Enoch; Clerk-Treasurer Karen Dinger; Town Marshal Terry Moore and Public Works Commissioner Steve Stout present. C/T Dinger presents claims from October 14 to November 10, 2020 for both town and wastewater for a total of \$155,038.44 which includes \$122,000 in investment monies that will be moved to Trust Indiana. Enoch makes a motion to pay the sewage and town bills. Michael 2nds. All Ayes. Motion Passed.

Public Works Commissioner Steve Stout provides an update. A lot of leaves have been picked up. Work has been done on the wastewater line out at the sewage plant to help clean out built up silt.

Two quotes from Skiles Electric are presented. The first quote received for \$2,195 is to make the wastewater lift station electric panel on 8<sup>th</sup> Street/Cutler Road match the panel at the Haun Drive lift station. The second quote received for \$7,730 is for work at the Zook Lane lift station for new floats and a new electrical box. Michael makes a motion to spend \$2,195 on 8<sup>th</sup> Street and \$7,730 on Zook Lane for those repairs. Enoch 2nds. All Ayes. Motion passed.

The town has applied for CARES Act public safety personnel payroll reimbursement monies for March 1 through September 30, 2020 and that application has been approved. The town will receive a total of \$19,531.00
