The Burlington Town Council held a regular monthly meeting on Tuesday, April 13, 2021 at 7:00 p.m. at Town Hall with Council's Steve Michael, Kevin Hammond and Jim Enoch; Clerk-Treasurer Karen Dinger; Town Marshal Terry Moore and Public Works Commissioner Steve Stout present. Attorney Justin Alter attends by phone.

Guests present are: Julia Leahy, Roger Bousum and Susan Scholl

Council President Steve Michael calls the meeting to order at 7:00 p.m.

C/T Dinger presents meeting minutes from the March 9, 2021 council meeting. Michael makes a motion to accept the minutes from March 9, 2021. Enoch 2nds. All Ayes. Motion passed.

C/T Dinger presents claims for the town and wastewater from March 10 through April 13, 2021 for \$37,827.76 total. Enoch makes a motion to pay the bills from March 10 to April 21, 2021. Hammond 2nds. All Ayes. Motion passed.

Marshal Moore presents monthly marshal's report. There were 73 written warnings for the month. The marshal is applying through the state for new computers and printers for the police vehicles for the e-ticket system. The officers recently attended a training in town with a company that sells police drug testing kits utilizing test strips. The department purchased several kits and utilized them during a recent stop. The kits worked really well and are safer to use as any substance does not need to be put in a separate vile for testing. The bars for the back window of the police truck are in. Installation will be completed once the company doing that is available to do so. Michael makes a motion to accept the marshal's report as presented. Enoch 2nds. All Ayes. Motion passed.

Public Works Commissioner Steve Stout speaks to the council regarding renting dumpsters for this year for town cleanup. Discussion is held. Enoch makes a motion to do the dumpsters in the fall. Hammond 2nds. All Ayes. Motion passed. Stout states that Kevin from Alliance of Indiana will be here Monday to look into something that has been coming in out at the sewage plant.

### **Old Business**

It is noted that transferring the police car to the school is waiting for the school board to establish the police department at the school.

Abandoned Buildings – Kamron Yates from the Area Plan Commission stated that the council can get together a listing of buildings and he can look at them to see if further action is needed.

Julia Leahy from the Carroll County Chamber of Commerce addresses the council. The annual chamber dues are presented. The dues were included in the claims and will be paid tomorrow. April 30 is the State of the City, County and Towns Luncheon from noon to 1:00 p.m. at the canal center. She would like to see if someone from Burlington would be able to share about five minutes of updates for the town at the luncheon. Saturday, May 1 there will be a ribbon cutting at the new coffee shop here in town. She states that they are updating the community guide. Discussion is held regarding unlicensed vehicles in need of repair. A list will be compiled.
