**November 10, 2015**

The Burlington Town Council held a regular monthly meeting on Tuesday, November 10, 2015 @ 7:00pm in Town Hall with Council's Stan Moore, Teddy Huffer, Steve Michael; Clerk-Treasurer Karen Dinger; Town Marshal Jill Hammond; Town Attorney Justin Alter; and Public Works Commissioner Steve Stout present.

Council President Moore opens the meeting at 7 p.m.

**Town Business**

C/T Dinger presents minutes from last month's meeting. Huffer moves to approve minutes as presented. Michael 2nds. All Ayes. Motion passed.

C/T Dinger presents claims from 10/14/15-11/10/15 for Town and Wastewater. Huffer motions to pay claims as presented. Michael 2nds. All Ayes. Motion passed.

Carroll County Chamber of Commerce Executive Director, Julia Leahy, presents information and a letter from the Chamber regarding changes in appropriation from the county and a request for an increase in funding in 2016. Moore makes a motion to table this until the December meeting. Huffer 2nds. All Ayes. Motion passed.

Town Marshal Hammond presents monthly marshal and deputy marshal reports. Huffer moves to approve reports as presented. Michael 2nds. All Ayes. Motion passed.

Town Marshal Hammond requests the council to upgrade the Tazer and handgun for the police department. Moore asks for prices and requests Dinger to look at available funds.

Park Superintendent, Mike Mann gives an update on the park. He states that new dog park equipment will be installed in the spring. There is an area K-9 officer who comes here to train. He states that the new veteran memorial at the park is a great asset to the park and looks very nice.

Vice-President Huffer gives an update on the park board. The board is looking to re-roof the Kirkendall Shelter and is getting bids.

**Old Business**

C/T Dinger presents Ordinance 2015-7 as drafted by Attorney Alter. Ordinance title 2015-7 is read, "An Ordinance Repealing and Licensing the Conduct of Certain Activities within the Town of Burlington." Michael motions to adopt Ordinance 2015-7, Huffer 2nds. All Ayes. Motion passed. Ordinance will be published in the newspaper.

The animal ordinance draft is discussed. Moore makes a motion to table the animal ordinance, Michael 2nds. All Ayes. Motion passed.

Discussion on the firearms ordinance draft. Huffer makes a motion to table the Firearm Gun and Bow Ordinance. Moore 2nds. All Ayes. Motion passed.

**New Business**

It is noted that Art in the Park is being held on Friday, November 13. The Burlington Christmas Walk is Saturday, December 5.

Steve Michael gives an update on the Family Health Clinic. He states that demo has begun.

Public Works Commissioner, Steve Stout, gives an update. He is preparing for winter. Oil will be changed in the ToolCat. Ice melt that works to 35 below will be on hand to use this winter. He also notes that they have picked up a lot of leaves.

Vice-President Huffer requests to go to the Carroll County Commissioners to request changing incorrect address on West Third Street. Moore makes a motion to allow Huffer to represent the council. Michael 2nds. All Ayes. Motion passed.

Michael motions to adjourn. Huffer 2nds. All Ayes. Meeting adjourned.
