Town Business

C/T Dinger presents minutes from the April 12, 2016 regular meeting. Michael makes a motion to accept minutes as written. Huffer 2nds. All Ayes. Motion passed.

C/T Dinger presents claims from 4/13/16-5/10/16 for Town and Wastewater. Moore makes a motion to pay bills as presented. Huffer 2nds. All Ayes. Motion passed.

Council reviews the April marshal and deputy marshal reports as submitted. Huffer moves to approve reports as written. Michael 2nds. All Ayes. Motion passed.

PWC Steve Stout gives an update. The new building at the sewage plant is up. It will be completed when the doors are installed. The zero-turn mower at the plant is in need of a new gear box. Moore makes a motion to get the gear box. Michael 2nds. All Ayes. Motion passed. Discussion is held regarding the sink hole on 7th Street. Steve will look at that tomorrow.
