The Burlington Town Council held a regular public meeting on January 8, 2013 @ 7:00pm in Town Hall with Council's Moore, Huffer, and Armstrong; Town Marshal Jill Hammond, Town Attorney Justin Alter and Clerk-Treasurer Karen Dinger present.

Council President Moore opens the meeting.

C/T Dinger presents minutes from regular meeting December 11, Executive Session December 11, and end of year public meeting on December 27. 2012. Armstrong motions to approve all three meeting minutes. Huffer 2nds. Motion passed.
