C/T Dinger presents an agreement between the Town and Burlington Community Club for payment from the town for cleaning of the Community Building and Lilly Building at the park. Michael makes a motion to accept agreement. Moore 2nds. All Ayes. Motion passed.

A new lease is presented for renting of Town Hall from JKAB Properties. Huffer makes a motion to adopt renewing the lease agreement. Moore 2nds. All Ayes. Motion passed.

A special year end meeting is scheduled for Tuesday, December 27 at 6:30 p.m. to conduct year end business.

The 2017 salary ordinance is discussed. It will be passed at the year-end meeting.

The 2017 Public Works Commissioner Contract is presented and discussed. Huffer makes a motion to table PWC contract due to wording changes needed. Michael 2nds. All Ayes. Motion passed.

The 2017 Town Marshal Contract is presented. Moore makes a motion to approve Town Marshal Contract. Michael 2nds. All Ayes. Motion passed.

Discussion is held between the council regarding a guardrail on the turn of Jackson and 3<sup>rd</sup> Streets. Advice is requested from counsel. Attorney Alter thinks it would be a good idea.

Councilmember Michael states that three bids were requested, with only one response received. The bid received is for \$3437.50 from James Drew Corporation. Moore makes a motion to contract James Drew Corporation to put the guardrail on 3<sup>rd</sup> Street. Michael 2nds. Moore and Michael vote Aye. Huffer votes Nay. Motion passed.
